It is proposed to fill up 50% of the net Direct Recruitment Quota vacancies in the category of Junior Translator (Hindi) in Pay Matrix Level 6 (GP.Rs.4200/-) in Southern Railway through General Departmental Competitive Examination (GDCE).

2. The detail of posts in the category of Junior Translator (Hindi) for which GDCE is to be conducted is as under:

3. In terms of Board's instructions " employees working in Lower Grade than the Grade for which GDCE is held alone will be allowed in the GDCE".

4. All the serving regular Group 'C' employees of Southern Railway working in all departments/Units of Headquarters/Divisions/Extra Divisions, Construction units & ICF/PER in Pay Matrix Level 5 (GP.Rs.2800/-) or below i.e. Pay Matrix Level 1 or 2 or 3 or 4 (GP.Rs.1800/-, Rs.1900/-, Rs. 2000/-, Rs. 2400/-) (except RPF/RPSF) with the following educational qualification and age are eligible to apply.

(a) Educational Qualification/

(I) Master's degree of a recognized University or Technical Qualification equivalent in Hindi or English with English or Hindi as a compulsory or elective subject or as a medium of examination at degree level.

OR

Master's degree of a recognized University or equivalent in any subject other than Hindi or English with Hindi or English medium and English or Hindi as compulsory or elective subject or as a medium of examination at degree level.

OR

Master's degree of a recognized University or equivalent in any subject other than Hindi or English with Hindi and English as compulsory or elective subject or either of the two as medium of examination and other as a compulsory or elective subject at degree level.

AND

(II) Recognized Diploma or Certificate Course in translation from Hindi to English and vice-versa or two years' experience of translation work from Hindi to English and vice-versa in Central or State Government offices, including Government of India Undertaking.

OR

Translation Training Course Certificate of three month duration awarded by Department of Official Language, Central Translation Bureau, M/o Home Affairs.

b) Maximum age limit as on 01.07.2019.

5 (a) Eligible Group 'C' regular employees may submit their applications in the enclosed prescribed format, duly filling all the columns and the same shall be verified and certified in the appropriate column in the enclosed proforma by the concerned supervisory officials. Any information given in the applications, if found false or incorrect at a later stage will result in disqualification of candidates, apart from initiation of disciplinary action.

(b) The eligible volunteers should send their application duly filled in & certified by Supervisory Officials in the prescribed format directly to RRC/Chennai to the address mentioned below by post or in person. The last date & time for receipt of applications in RRC/Chennai is 29.07.2019 at 17.30. hours. The last date & time for receipt of application in RRC is "SACRO SANCT". There is no need to attach the attested copies of certificates in proof of their passing/Matriculation, +2/Pre-Degree and Degree in any discipline for educational qualifications and community Certificate in the case of SC/ST/OBC, which will be called and verified for the qualified candidates during document verification.

6. The applications received will be treated as "Invalid/Ineligible" on the following grounds:

1. Applications not in the prescribed format/missing columns
2. Incomplete / ineligible applications
3. Applications unsigned / signed in capital letter
4. Applications with Left Hand Thumb Impression not affixed/blurred/smudged
5. Applications of over-aged candidates
6. Applications received after closing dates &
7. Application without verification and certification of Supervisory Officials.

7. a) As the vacancies of Jr. Translator (Hindi) under GDCE are assessed covering all Divisions/Units of Southern Railway, the employees who are selected are liable to be posted to any division/units of Southern Railway. Those who are not willing for posting involving transfer, need not apply.

b) The allotment of division of the selected employees will be at the discretion of the Administration, subject to availability of GDCE quota vacancies. The applicants cannot claim for posting as per their choice.

8. The GDCE will consist of Written/*Online* examination, Translation test, verification of certificates and medical examination. The panel will be formed strictly in the order of merit. The standard of the written examination under GDCE shall be that prescribed for Direct Recruitment Quota on open competition for this post.


9. Only those candidate who secure the requisite qualifying marks in the written examination and Translation test are eligible to be empanelled for appointment as Jr. Translator (Hindi) on the basis of the marks obtained in the written examination, They should also be fit in the prescribed Medical Classification of CEE-TWO for Jr. Translator (Hindi) before they are appointed.

10. The final empanelment for the vacancies notified would be as per eligibility & merit.

11. This notification may be given wide publicity by circulating to each and every station and depot of Divisions/units and pasting on Notice Boards at prominent places.
